I am writing to formally request an opportunity to address the council regarding the Maskwa Medical Center a community-driven transformative initiative aimed at enhancing healthcare accessibility and outcomes across Northwestern Alberta. Operating as a publicly funded, not-for-profit medical facility in Grande Prairie starting in 2026 under an innovative arrangement with the Government of Alberta the Maskwa Medical Center will see the development of a cutting-edge medical facility in Grande Prairie, Alberta designed to educate future medical professionals, provide team based diagnostic services to individuals in need of urgent medical assessments and offer comprehensive medical services.

The Maskwa Medical Clinic will be a leading medical clinic in Alberta, Canada for the diagnosis of medical conditions that are complex and difficult to diagnose. Bringing together top specialists and subspecialists from across the province the clinic will shorten the time to get a correct diagnosis contributing to improved health outcomes and quality of life for patients and their families while providing cost savings for both patients and Alberta's healthcare system.

The Maskwa Medical Center's Memorandum of Understanding with the University of Alberta's Faculty of Family Medicine will train more family physicians for rural Albertans in NW Alberta, thus improving access to family physicians. The objective is to elevate educational prospects significantly by fostering an environment where medical professionals can learn, practice, and immerse themselves in the community.

Fully Funded Services

There are NO fees charged to patients.

Maskwa Clinic will be funded through an innovative ARP arrangement with the Government of Alberta and philanthropic initiatives. Specialists will be salaried based on 5 DAYS a week, 8 AM to 5 PM.

The financial & operational performance of Maskwa is overseen by its Board of Directors and is **accountable** to the Government of Alberta for its billing to the Alberta Health Care Insurance Plan (AHCIP) for the services of physicians and specialists in the diagnosis of diseases and its use of other public funds to provide services.





Patients requiring a specialist visit for a new illness or condition between 2009 and 2013 had to wait longer than 3 months*. The average time Alberta patients wait for a referral by a general practitioner to seeing a specialist has grown from 3.6 weeks in 1993 to 13.3 weeks in 2020**.


Our goal is to get patients set up with a treatment plan within 10 days of walking through the Center's doors.

Maskwa vows to ensure patients **do not get stuck in the referral cycle** by using virtual conferencing technology.


This process philosophy will **save time and money for patients and caregivers** related to taking time away from work, travel and accommodation expenses.



First Floor – University of Alberta Academic Teaching Clinic

- 22,000 sq ft of teaching space within the Maskwa Medical Center
- 20 RESIDENCY STUDENTS onsite, 10 first-year and 10 in the second-year residency program, graduating 10 secondyear students as Physicians into NW Alberta communities per year.
- Each Graduated Family Physician will have the training to see between 900 – 1100 patients per year in the community in which they work.

Future Medical School Opportunities

Recruit rural + Train rural = Retain rural

- Maskwa Medical Center is a key partner in training for medical program and will house the teaching clinic for medical students and Family medicine residents.
- Clinic will have extended hours of practice including evenings and weekends to reduce pressures on Emergency Departments by 50%.
- Focus of Northern Alberta Medical Program (NAMP) is to recruit students from rural AB & BC, train them in Grande Prairie & Northern communities, and then they will stay in practice in the Northern communities. We know this works based on Prince George BC model where 75% of graduates are practicing in rural and regional communities.

Medical School & Residency Program

Two components of training to become a Doctor

1. Undergraduate Medical Education at NWP (medical school)

- Basic training to obtain a Medical Degree (MD) 4 years
- Enrolling up to 30 medical students per year at NWP, starting Sept 2025.
- All 4 years of medical program delivered in GP & northern communities.

2. Residency Training at Maskwa Medical Center (U of A)

- Specialized training, after completing 4 years of Undergraduate Medical Education.
- Family medicine 2 years
- Other specialties such as Surgery, Internal Medicine,
 Obstetrics require 4 -5 + years

- Collaboration with the Maskwa Medical Center and its partners on training and employment opportunities for NWP graduates will keep our talent in the region.

RE: Changes to the Recreation Membership Fee Schedule

Administration will be doing an overall amendment to the Fees & Charges Policy to bring back to Council by the end of November 2024 for a January 1, 2025 implementation.

Administration is recommending the proposed changes to Recreation Membership fees to align with market rates and structure comparable to other facilities in Northern Alberta.

The recreation membership and drop-in rates will include all-day access to all Town of Beaverlodge drop-in recreation activities. One rate will cover drop-in access to the fitness center, drop-in aquatics programs, in-water and dryland fitness classes, public skating, and stick and puck programs at the arena.

Other changes include increasing the age of free children, adding 'Super Seniors', and improving access to the Recreation Fee Assistance program. The Recreation Fee Assistance program will expand to include recipients of Government of Alberta Income Support, recipients of Federal or Provincial disability benefits, and children under government care.

Fees for the Recreation Center were set initially when the facility opened in 2012 and amended for January 2020. To mitigate the challenges of a one-time significant increase fees will be increased over 2 years.

Included are the current and proposed rates.

DEER MANAGEMENT TECHNIQUES

- Home remedies: hanging out bars of heavily scented soap or nylon bags of human hair may work until the deer become used to the scent.
- Commercial repellents: products can be purchased that are applied directly to the plants which repel the deer by either adding a foul smell or taste. Always follow the manufacturer's directions. Be aware that when there is an increase in deer numbers or a decrease in alternative food sources, deer will continue to eat treated plants.
- Fencing: a deer-proof fence should stand at least 2.4 m (8 feet) high, be ground tight and made of durable wire mesh. Electric fencing is also an option. Install tall fencing or protective cages around prized plants to safeguard them from curious deer.
- Deer-resistant landscaping: though hungry deer will feed on nearly any type of vegetation, planting ornamental trees, shrubs and flowers that are not as attractive to deer is one way to preserve your landscaping efforts. Check with your local gardening centre to find out which deer-resistant plants will grow best in your area. Utilize Gravel as a Natural Deterrent: Deer dislike walking on gravel, making it an effective barrier around garden beds. Create a protective perimeter to discourage their presence.

 Commercial scaring devices: devices that produce a siren-like sound can be found in hardware or garden supply stores. These devices can successfully deter deer and other wildlife from damaging plants and trees, provided you begin using them before the wildlife becomes used to the food source.

Deer Management

Managing wildlife in urban areas can be challenging, but there are effective strategies to help minimize conflicts between humans and wildlife. One key approach is community education. Residents should be informed on how to safely manage wildlife encounters and, ideally, how to avoid them.

Education, habitat management, and non-lethal methods of deterrence are all important tools in managing urban wildlife. By working together, we can ensure that wildlife populations can thrive while also keeping humans and pets safe.

It can be frustrating to find that deer have devoured the plants, flowers, and shrubs you've worked so hard to cultivate. In our community, where deer are plentiful, developing a solid plan to make your yard and garden less appealing to them is essential.

As the pressure on these animals to find food sources increases, it's important to adopt a comprehensive approach to protect your outdoor spaces. Consider these tips to help safeguard your garden from deer intrusion:

- If a deer has found its way into your backyard, it can find its way out. Bring your children and pets into the house to minimize the stress on the visiting deer and wait for it to leave.
- Do not let your dog bark at or antagonize the deer. This can further stress the deer and lead to aggressive, self-defensive behaviours.
- Never feed deer. Deer can feed themselves, and leaving out salt blocks to attract deer may also attract the larger carnivores that prey on deer.
- Remove all food sources that may attract a deer, such as fallen apples and bird seed spilled from bird feeders.

BYLAW #1021

PROHIBIT THE FEEDING OF WILDLIFE IN THE TOWN OF BEAVERLODGE

The Wildlife Feeding Bylaw (#1021) of the Town of Beaverlodge prohibits feeding wildlife within town limits.

It is illegal to store, handle, or dispose of wildlife attractants in a way that makes them accessible to wildlife, and individuals are forbidden from feeding or attempting to feed wildlife, either directly or indirectly.

Exceptions to this rule include activities by wildlife officers, farm operations (unless negligent), fruit and vegetable gardening, and ornamental plants.

Residents are allowed to use bird feeders, but they must ensure they are not accessible to other wildlife.

If a device or feed attracts wildlife, property owners must remove or modify it within 24 hours of notice. Failure to comply may result in penalties, and enforcement officers are authorized to take action to address violations.
