Dear Sponsor,

We are **very excited** to announce the start of a new beginning for the Beaverlodge Elementary School playground.

Beaverlodge Soccer Kits has been working with the Town of Beaverlodge since 2017 to find a suitable, permanent home for our club. For the past two years we have been able to create this home at the playground of the Beaverlodge Elementary School. Last year we were the beneficiaries of a club house, graciously donated to us by our counterparts in Grande Prairie, Swan City FC with whom we have merged since 2022. With the help of Beaverlodge Fire Department, Home Hardware, Ace Hardware, Anna's Pizza, IGA, Town of Beaverlodge and a group of youth volunteers this club house was cleaned up and brought to it's permanent home in the Recreation center parking lot. It was advised by the Town of Beaverlodge CAO that this would be the ideal location for this facility due to security reasons at other reasons in town.

The school playground offers us ample space to host all our players, with room to expand to host more players and tournaments in the future. We were ready to start leveling the play ground last year during summer break, it was however found that a cable runs under the soccer fields of the playground. The "cut and fill" approach that we had planned for no longer was an option.

Quitting, however, is a word we do not agree with. We have been working hard to get around this challenge and we have found it.

The Town of Beaverlodge had set aside a fund of \$25 000 previously to build a proper facility that is large enough to accommodate all our players in one location with future expansion in mind.

With an incredible donation from DRay Construction we are able to go to work this summer as soon as school is out for the summer. DRay Construction is donating all the clay to fill and level the low spots in the playground between the school building and parking lot of the Rec center (west side of the playground). This donation is worth just over \$16 000.

We need your help to fit all the pieces of the puzzle together.

BACKGROUND


The Municipal Government Act (MGA) provides Municipalities with the authority to levy property taxes and requires that specific measures be taken to collect those taxes.

Section 326(c) of the MGA defines "tax arrears" as "taxes that remain unpaid after December 31 of the year in which they are imposed". Prior to March 31st each year, a municipality must prepare a "Tax Arrears List" and submit it to the Land Title Office (LTO). The tax arrears list includes the properties that are more than one year in arrears. For example, properties with unpaid taxes for 2022 were included in the list prepared in 2024. LTO then registers a tax notification against the property title. The notification is only removed when property taxes are paid in full.

Where property taxes remain unpaid and are more than two years in arrears, the MGA, Section 418, states that the municipality **MUST** offer the land for sale by public auction. In order to avoid sale by public auction, a landowner may enter into a tax payment agreement whereby regular payments are made, and taxes are paid in full within three years.









THE PROCESS

As part of the public auction process, Council must establish a reserve selling price before it can auction a property. The reserve bid is set at a level that is as close as reasonably possible to market value of the parcel. The municipality may use a current assessment value or acquire the services of an independent, professional appraiser. For these bids we have used the current assessment value.

The public auction must be advertised in accordance with Section 421. A property owner or other interested party may pay the taxes or enter into a tax agreement at any time prior to the auction.

Where a property owner enters into a tax agreement and the property owner does not meet the conditions of the agreement, the Town must then proceed with a tax sale in accordance with the requirements of the MGA.

If the property is sold at public auction, the purchaser acquires the property free of all encumbrances, except encumbrances listed in Section 423(1) of the MGA.

If a property is sold at public auction (Section 427), the municipality must first pay the taxes and any remedial costs related to the parcel and any expenses owing to the Crown (Section 553). If there is money remaining, the municipality must take specific steps to notify the owners and secured creditors that application must be made to recover their monies.

Where properties are not sold at the public auction, the Town may take additional steps in collecting taxes. This includes transferring the title of the property to the Town and disposing of the property in another manner, or, in the case of a rental property, giving notice to the tenant that all rents are to be paid to the Town. Where rents are collected, the rents are distributed against the taxes. Once the taxes are paid, the title is revived in the name of the previous owner. Usually, where a property is not sold at public auction, a municipality will take title to the property and offer the property for sale in another manner such as by sealed tender.

COSTS


There are specific costs related to registration of the tax notices on the property titles, advertising, and administration charges. These costs are recoverable and are distributed between the specific tax accounts.

As of January 1, 2025 tax arrears owing to the Town for the above properties totaled \$21,885.05.











RECOMMENDATIONS

- That Council establish the date, time, and place for the public auction of tax arrears properties listed above in this report as Wednesday, September 10, 2025, at 10 am in the Beaverlodge Community Centre, 1016-4th Avenue.

CONDITIONS OF SALE


The conditions are as follows:

- GST will be added to all successful bids,
- A deposit of 10% of the successful bid payable in cash, certified cheque, bank draft or money order must be received upon acceptance of the bid at public auction,
- The balance payable in the same manner is due within 30 days of the date of the public auction,
- All properties are to be sold on an "as is, where is" basis and the Town of Beaverlodge gives no
 warranty whatsoever to the adequacy of services, soil conditions, land use districting, building
 and development conditions, absence or presence of environmental contamination, or the
 ability to develop the subject land for any use proposed by the Purchaser,
- No bid will be accepted where the bidder attempts to attach conditions precedent to the sale of any parcel,
- No terms and conditions of sale will be considered other than those specified by the Town.
- All sales are subject to the reserve bid and any conditions and/or reservations on the existing title, and
- Taxes to be adjusted as of December 31, 2025.

BACKGROUND


As with the recovery of taxes related to land, the *Municipal Government Act* provides specific instructions for municipalities in Division 8.1 in regard to recovery of taxes related to Designated Manufactured Homes (DMH's). The process is almost the same.

THE PROCESS

As part of the public auction process, Council must set a reserve bid before it can auction a Designated Manufactured Home. The reserve bid is set at a level that is as close as reasonably possible to market value of the DMH's. Council must also set conditions of sale.

The public auction must be advertised in accordance with Section 436.12. A property owner or other interested party may pay the taxes or enter into a tax agreement at any time prior to the auction. Where a property owner enters into a tax agreement and the property owner does not meet the conditions of the agreement, the Town must then proceed with a tax sale in accordance with the requirements of the MGA.

If the property is sold at public auction, the purchaser acquires the property free of all encumbrances, except encumbrances listed in Section 436.14(1) of the MGA.





If the property is not sold at public auction, the municipality has the right to sell or dispose of the DMH's as per Section 436.15 of the *Municipal Government Act*.

RECOMMENDATIONS

- That Council establish the date, time, and place for the public auction of tax arrears properties listed above in this report as Wednesday September 10, 2025, at 10 am in the Beaverlodge Community Centre, 1016-4th Avenue.
- 2. That Council set the reserve bids as listed above under Designated Manufactured Homes to be offered at the Public Auction.
- 3. That Council set the conditions of sale as follows:
 - The DMHs shall be offered for sale on an "as is, where is" basis and the Town of Beaverlodge makes no representation and gives no warranty whatsoever regarding the condition of the DMHs. No bid will be accepted where the bidder attempts to attach conditions precedent to the sale of any DMH. No terms and conditions of sale will be considered other than those specified by the Town of Beaverlodge.
 - The DMHs listed above shall be subject to the tax sale if the total outstanding property tax arrears remain outstanding prior to the tax sale.
 - The DMHs will be offered for sale by auction, subject to a reserve bid and to certain encumbrances as described in section 436.14 of the *Municipal Government Act*.
 - Payments by cash, certified cheque, bank draft or money order only. The successful bidder must, at the time of sale, make a non-refundable ten percent (10%) deposit payable to the Town of Beaverlodge, with the balance of the purchase price due within 30 days of the public auction.
 - Purchasers are responsible for obtaining vacant possession.
 - All sales are subject to current taxes.
 - GST may apply on DMHs sold at the public auction.
 - Redemption may be effected by payment of all arrears of taxes and costs at any time prior to the date of sale. DMHs may be deleted from this sale as the tax arrears and costs are paid.

RE: Sponsorship of "Miles for Smiles" Mental Health Awareness Run

Purpose:

To inform Council that Administration has approved a request to sponsor a local campsite for the "Miles for Smiles" mental health awareness run scheduled to pass through the Beaverlodge area in late June 2025.

Background:

Nicole Troyer, a 19-year-old mental health advocate and recent high school graduate from Grande Prairie, is organizing a cross-Alberta run to raise awareness for mental health and funds for **Solstice House** in Clairmont, Alberta. This initiative was inspired by her personal experiences and a desire to encourage open conversations about mental health struggles, particularly among youth.

Beginning June 10, 2025, Nicole will run approximately 790 km from Lloydminster to Demmitt, averaging 42 kilometres per day over three weeks. The route includes key communities such as Edmonton, Grande Prairie, and Beaverlodge. Nicole expects to pass through the Beaverlodge area between June 25 and June 28.

Request and Decision:

Phil Troyer, Nicole's father contacted the Town to request a sponsored campsite for the duration of their stay in the Beaverlodge area. The campsite would be used to park their holiday trailer, which serves as the base for Nicole and her support crew.

In exchange for this sponsorship, the Beaverlodge Pioneer Campground will be promoted on social media throughout the run via the event's public platforms (Instagram/Facebook: @mhawarenessrun). The promotion is expected to reach a wide audience, particularly among youth and mental health advocacy supporters.

Given the grassroots nature of the campaign, the message it promotes, and its alignment with community wellness and mental health awareness, Administration has agreed to provide sponsorship in the amount of \$200.00. The contribution will assist in offsetting logistical and operational costs of the initiative.

All outstanding funds after the duration of this run will be donated to **Solstice Integrated Wellness Center** which is a structured program for youth up to the age of 18 struggling with any form of addiction, trauma, eating disorders or any form of mental health concerns. They provide a variety of programs such as, voluntary and court-mandated detox and stabilization programs, educational programs for teens which include life skills, work experience, and social skills training. Solstice house is filled with wellness coordinators who ensure the emotional, spiritual, and physical health of clients throughout the period of their stay.

My name is Nicole Troyer, in June 2024, I graduated from high school in Grande Prairie, Alberta. I struggled with mental health quite frequently throughout the years. I was always surrounded by friends, but I couldn't shake the feeling of being alone. At 19, I often feel like I'm hovering between where I am and where I want to be. I didn't go to college right away or move out, seeing my friends build their futures makes me question everything. They seem happy, pursuing career dreams, they have a good job and a nice house! How could they be struggling too? Everyone has stuff they don't talk about and that's why I've decided to run across Alberta to raise awareness for mental health and those silent thoughts that people can't get out on their own.

On June 10, 2025, I will be running alongside the highway from Lloydminster to Demmitt to raise awareness for mental health. Starting in Lloydminster, running through Edmonton and Grande Prairie, and finishing in Demmitt. I plan to run 42km a day, making it across Alberta in just under 3 weeks. I will be splitting the marathon into 3 sections, run the first 21km, walk 10km, and finish off running the last 11km. I did this with the intent that people would come join the run, if you aren't a runner, come join the walk or bring a bike. Following close behind me will be a camper, where I will sleep, eat and shower. When the recorded 42km is completed, I may be miles away from a "parkable" location. If this happens, I will mark the spot with spray paint, drive to the nearest spot to camp, and then return to the marking the next day to continue running.

The biggest question to this run is, why? Why would I do something so extreme to raise awareness for something everyone knows about? A few years ago, someone very close to me attempted suicide. It was heartbreaking but I never imagined I'd have to go through it again. Then, just a few months ago, another loved one did the same, but this time, I stood there, watching helplessly as paramedics fought to revive her before rushing her away in an ambulance. I struggle every day feeling so angry, followed by guilt because I know what it feels like to be at that point. We shouldn't have to see people on a stretcher to realize they are struggling. We see people every day going to work and taking care of themselves, but still fighting battles all day long. The degree of someone's mental health struggles does not determine its importance.

Growing up, I watched in awe as my Dad crossed the finish line after running over 20 hours during a race. In 2019, I started running with him, from a quick lap around the block to running our first ultramarathon together in 2022. The longer I run, the more exhaustion sets in, not only physically, but mentally as well. Yet, in that exhaustion, my built-up emotions surface, the fight or flight response fades, and I find clarity in the chaos that once overwhelmed my mind. Throughout this run, I wish to give the awareness that I understand the negative thoughts and horrible feelings, I will be joined by people who also understand and relate. We are running for you, to make you feel heard and seen.







Dear Mr. Johnston,

Please find attached the quarterly Community Policing Report covering the period from January 1st to March 31th, 2025. This report provides a snapshot of human resources, financial data, and crime statistics for the Beaverlodge Detachment.

As we approach summer, I would like to highlight the preparations that the Alberta RCMP have made to address what may be another busy wildfire season. The wildfire seasons of 2023 and 2024 have provided our organization with many lessons on the best ways to handle the unpredictability of wildfires. In March, we began planning for the 2025 wildfire season and this included the early staffing of our Division Emergency Operations Center (DEOC). In the past two years, DEOC has been the cornerstone of the police response to the wildfires in Alberta. The members and staff in DEOC are able to process information from various sources to determine the most optimal way to deploy police resources in areas under threat of wildfires.

Depending on the severity of the fire season, it may be necessary to draw resources from your police service to ensure the safety of people and property in affected communities. I want to assure you that the Alberta RCMP will keep the needs of your community in mind and will work to deploy only the resources which will not adversely impact the security of our own community. The Alberta RCMP remains ready to respond to wildfires in coordination with other provincial resources to protect our citizens and communities.

Thank you for your ongoing support and engagement. As your Chief of Police for your community, please do not hesitate to contact me with any questions or concerns.
